FEE OF OTHER BRAND FACILITY:- This facility to the store partners will be given free of cost. No charges will be taken for this facility.

FACILITY TO ADMIN STORE PARTNER:- Admin store partner can use these facility as mentioned below

1. OTHER BRAND MASTER:- In this section admin store partner can add these services

A. ADD VENDOR:- "vendor" means that other brand products purchased from whom is called vendor. Admin store partner can add vendors.

B. ADD PRODUCT GROUP:- "Product Group" means product category as personal care, health care, baby care etc. He can add product group.

C. ADD SIZE:- admin store partner can add size as XL, L, M etc

- D. ADD UNIT:- Admin store partner can add unit as 100 ML, 100 GM, 1KG, 500 ML ETC.
- E. ADD COLOR:- Admin store partner can add color as red, blue, yellow etc F. ADD PRODUCT:- Admin store partner can add other brand products other than Negocia brand means which products are not available in Negocia can only be added by the store partner which will be approved by the Admin of Negocia.
- 2. OTHER BRAND SALE:- other brand products can be sold to DSA/ STORES by the stores partners.
- 3. ADD STOCK/ INVENTORY:- Inventory of other brand products can be added by the store partners and he can check stock report also.
- 4.BV, ADMIN CHARGE & REFERRAL BONUS:- When Admin store partner purchase other brand products from the Vendors, he has to be added in the system. There is auto updated system for BV Generate, admin charge and referral bonus as under.

6. BILLING & BV UPDATION ON DSA ID: Admin store partner can start billing of other brand products to DSA till the weekly closing date, invoices will also generate but BV Updation on DSA ID will be in unapproved orders/ in pending status. When the Admin store partner willdeposit closing amount to the company and company will approve the payment of that store, BV of DSA IDS automatically updated.

RULES OF CONDUCT

Any Violations of the Below said Rules will result in Termination of the other brand facility or termination of Negocia Store Partnership. Negocia reserves the right to modify and make any amendments in these rules from time to time when the Company deems it proper and Necessary.

1. Application for other brand facility.

- a. Any Company/Corporation, Proprietor/Partnership, Private or Limited Company when apply for other brand facility to the store should be a registered DSA.
- b. An Applicant Must Completely & Personally fill up the Application duly Signed in clear & legibly in Block letters to Signify his acceptance of all the Terms of the Rules and Regulations of Negocia. Incomplete information will not be processed on time.

2. Guidelines to add other brand products

A. Only those products will be added in the system which are not available in Negocia. In future If Negocia launched such products on Negocia Brand which are being sold in the other brand facility by the store partner, at that time the power of selling such products will be discontinued with immediate effect but prerior information will be given to the store partners. B. Best and premium quality products will be added. No compromising in quality. If any complaints received to the company about poor quality, the facility of other brand products will be terminated. C. If any health issue comes to the notice of company or food & drugs department may check products quality of other brand products or any complaint lodged by any of the customers in any of the police station due to the other brand products quality sold by your store, this will be totally store partner's responsibility and legal action if any will be dealt by the store partner not by the company. Company has given only service to sale other brand products. This is the store partner's responsibility to maintain good quality in other brand products.

3. Responsibilities and Duties:-

- a. To follow all guidelines, code of conduct of Negocia company.
- b. Ensure timely Deposit of closing amount to the company.
- c.Ensure Billing on same day and handover invoice printout to the DSA.
- d.Ensure sufficient stock at the store.

4. Termination or Cancellation of other brand facility/ Negocia Store Partnership

- a)Negocia has every right to terminate the other brand facility/Negocia Store Partnership for Non-Compliance, breach or violation of any of the stated Code of Ethics and Rules and Regulations and Policies of Negocia.
- b) Negocia Management will do Proper Evaluation of the Cause of the termination of other brand facility
- c) The Negocia Store may need to surrender his/her Accountabilities with the Company and other Negocia store.
